

ANNOUNCING THE FINALISTS FOR THE 8TH ART AND OLFACTION AWARDS **For Immediate Release**

April 22, 2022

Los Angeles – After a year's covid-induced hiatus, judges and board members joined together to announce the finalists of the 8th Art and Olfaction Awards in an online event on April 22, 2022. They were joined by hundreds of people from around the globe for an uplifting gathering that celebrated the finalists, and the resilience and creativity of the global community of scent-makers, perfumers and artists as a whole.

Awarded to just eight projects and perfumes per year, **The Art and Olfaction Awards** are designed to celebrate excellence in independent perfumery, and raise public interest and awareness around new developments in perfumery, on a global scale.

The Art and Olfaction Awards, established in 2014 by **The Institute for Art and Olfaction**, are given to outstanding creators in the categories of independent, artisan, and experimental perfume from across the globe, chosen for perfumes and experimental projects with scent released in 2020 and 2021. In addition to those juried categories, the Art and Olfaction Awards honor excellent work with three discretionary awards: *The Contribution to Scent Culture Award, The Septimus Piesse Award for Exceptional Vison*, and the Aftel Award for Handmade Perfume.

This year's **Art and Olfaction Awards** events will take place at the World Perfumery Congress in Miami on July 1, 2022. This marks a new collaboration between the Art and Olfaction Awards and the World Perfumery Congress (presented by the American Society for Perfumers). We believe that this collaboration marks an important step in creating better connections between different segments of the perfume industry. By placing independent, artisan and experimental practices with scent in the context of the larger industry, we hope to highlight the creative impulse that drives us all.

As with past years, our panel of exceptional judges included Anahita Mekanik, Andreas Keller, April Long, Ashley Eden Kessler, Chi Wai Tang, Dana El Masri, Daniel Krasofksi, Darin Klein, Ida Meister, Jeanne Doré, John Biebel, Julianne Lee, Kaya Sorhaindo, Klara Ravat, Lakenda Wallace, Mandy Aftel, Mark Behnke, Matthias Tabert, Maxwell Williams, Rubia Chaudri, Sarah Horowitz-Thran, Simon Niedenthal, Yosh Han. These people served as judges for no personal gain, as a service to the community. Judging is blind in the artisan and independent categories, and for the Aftel Award for Handmade Perfume.

Partners for the 8th Art and Olfaction Awards include Pochpac, Esxcence, World Perfumery Congress, the American Society of Perfumers, and more to be announced.

In addition to the three categories listed above, the Art and Olfaction Awards gives three discretionary awards.

<u>AFTEL AWARD FOR HANDMADE PERFUME</u>

Given to one outstanding small batch perfume that was 100% perfumer-created, in-house, with no use of outsourced compounding or expansion at any stage of the process. The winner is selected blindly by a special jury out of the top ten qualifying artisan submissions.

<u>CONTRIBUTION TO SCENT CULTURE AWARD</u>

This award will be given to one outstanding person who made significant contributions to global public awareness of artisan, independent and experimental practices with scent in 2020/21.

SEPTIMUS PIESSE VISIONARY AWARD

This award will be given to an outstanding person showing proof of exceptional vision with regards to how scent is used, developed, or imagined.

We will announce all winners at the 8th annual Art and Olfaction Awards, on July 1, 2022. Each winner will receive *The Golden Pear*, which continues to cement its status as an important achievement in the perfume world.
